

ADVERTISEMENT FOR BIDS

Sealed bids will be received for the CDBG No. 19b-y-114-1-6086, Storm Drainage and Street Improvements, Hill Top Community at the Pike County Board of Commissioners, 331 Thomaston Street, Zebulon, GA, 30295 until 11:00 A.M. (Local Time), on Tuesday, September 29, 2020, at which time they will be publicly opened and read at the Pike County Courthouse, 16001 Barnsville Street, Zebulon, Georgia 30295 in the second floor court room.

The work under this Contract will consist generally of the following:

Roadway construction, including traffic control, erosion control measures, and construction of ± 2.77 Lin. Miles of mainline roadway grading, $\pm 1,008$ TN of 12.5 mm RAC superpave asphalt for leveling, signage, striping, and all other necessary appurtenances for a complete job.

All work on the Project must be completed within 180 consecutive calendar days of date of notice to proceed.

Bids arriving after the designated time will be returned unopened.

No bids shall be withdrawn for a period of 60 days after the opening of bids. Pike County reserves the right to reject any or all bids and to overlook and/or disregard informalities or irregularities in the proposals.
